Is it easy to use?

The Business Crime Reduction Partnership uses the DISC system which is intuitive and simple with easy navigation throughout. The online scheme can also be used to support any radio system already established or become a dual radio and online scheme (additional radio cost will apply).

How do I stay informed?

Alerts and e-newsletters keep members up-to-date with criminal activity, crime trends and scams. The BCRP facilitates meetings for local areas, districts and the county welcoming representatives from each area from its members. The members are the driving force for this partnership giving businesses a voice to improve their town or city.

Where do I share information?

Online incident and intelligence reporting via the intranet system, including internal CCTV images.

What analysis data will I get?

Embedded analytics to identify crime trends and 'hotspots'.

Is it legally compliant?

Fully compliant to General Data Protection Regulations (GDPR), Data Protection Act 2018 (DPA 18) and registered with the Information Commissioner's Office (ICO).

How secure is the data?

The intranet system is built around the highest data security standards which ensures that the BCRP data is as secure as possible; in line with GDPR and DPA 18, with auditable traceability.

What if I'm not at my desk?

The BCRP intranet system has its own smartphone app with a unique 'remind me later' incident reporting function, and access to offender galleries while you're on the move.

Partnership success

Derbyshire BCRP is a joint project funded by East Midlands Chamber and the Derbyshire Police Crime Commissioner's Office.

It is one of several hundred national schemes and is currently running in a number of Derbyshire towns.

The scheme is delivered in partnership with the police, local councils, community safety and support services to help those businesses with complex needs.
